All officer(s) interested in attending this course MUST go through a criminal history check and if approved by ASSIST 14 Board - they then will be allowed to attend!!

Equipment needed if approved: A cased/unloaded duty weapon, duty belt holster (inner belt and outer belt with Velcro or 4 keepers), 3 magazines or 2 speed loaders for your weapon and a cleaning kit. Officers should bring 650 rounds of handgun ammunition for use throughout this 40-hour training.
