Item No. 6 on the Agenda - Approval of Minutes - November 15, 2023

FY'2025 - Proposed Training Budget Overview

Director Williams stated that the Budget Committee met and approved the FY'25 Training Budget with a 5% increase to account for inflation.

At the ILETSB meeting last week it was announced that funding levels for FY'25 were likely going to remain at the same level as FY'24. Director Williams stated we should know by the May meeting at what level our budget will be approved.

Motion was made by Director Rohlfing and seconded by Director Presson to approve the FY'25 Training Budget. Motion carried with no dissenting votes.

Director Williams stated that President Watson appointed the 2024 Nominating Committee, which consist of one person from each County.

FY'2025 - Statement of Partnership Agencies

Director Williams stated that we have received about 50% of the FY'25 Partnership Fees. We are on track to receive 98% of all the FY'25 Partnership Fees by the due date.

Director Williams announced that we lost Alton & Southern RR and Irvington PD as Partnership agencies. Both were disbanded due to size. Director Williams foresees that we may lose more Partnership agencies in the future for the same reasons.

Item No. 10 on the Agenda - Staff Activity Report

Asst. Director Schmoll went over the following staff activity.

a. January 18, 2024 - Awards Banquet Update

We had 292 in attendance and 46 awardees.

Total Cost - \$20,267.13 SILEC Paid - \$10,272.66

SIPCA Paid - \$10,469.52 *(1) SIPCA Plaque

Asst. Director Schmoll announced the 2025 Awards Banquet will be at the Four Points Sheraton-Fairview Heights, IL. on Thursday, January 23, 2025. He reminded the directors to be thinking about nominations for next year's Awards Banquet. Director Williams invited the SILEC board to attend the banquet and to contact our office to make arrangements.

- c. SILEC hosted 79 courses, trained 2,141 Officers, for a total combined 7,271 Hours of training from November 15, 2023 through March 13, 2024.

New Director Matthew King thanked the committee for the opportunity to serve on the SILEC Board and thanked the board for all the work they do.

Director Williams invited the SILEC Board Members on a tour of the Southwestern Illinois Justice & Workforce Development Campus after the meeting.

Director Connor asked Director Williams to give a brief explanation of the Partnership Fee funding structure and the size of the MTU and who it covers for the new members of the SILEC Board. Director Williams explained we currently have about 100 partner agencies. We cover about 1,500 police officers and about 450 civilian employees that we provide training. Each agency pays an annual fee of \$100 per officer and

telecommunicator, which allows them to attend any of the trainings we host for free. The seven member counties pay more and have different fee structures based on the larger amount of officers that need training. We also allow Federal and State agencies or members of other MTU's to attend our trainings if there are seats available. Director Williams gave the example that recently a National Park police officer affiliated with the Arch Memorial Grounds in Missouri attended a training hosted by SILEC.
